# 1. APOLOGIES FOR ABSENCE

Councillor JK Hall (Vice Chairman) and E Simons sent their apologies for the meeting.

# 2. DECLARATIONS OF PECUNIARY INTEREST

Cllr N Other declared a pecuniary interest in relation to the planning application 18/000613/FUL, he took no part in the discussion, or voting on this application.

#### 3. MINUTES OF THE PREVIOUS MEETING

The minutes of the meeting held on 25<sup>TH</sup> July 2018 were approved and signed as a true record of the proceedings of that meeting.

#### 4. MATTERS ARISING FROM PREVIOUS MINUTES

Planning Application Burgesses, High Street

In addition to the previous recommendation to refuse this application we would like to add the issues relating to the sewerage problems in that end of the village. Currently they are overloaded and the residents in the area of Dark Lane, Mill Lane etc experience on a regular basis problems. There are pumps that have to run (which have been report to Severn Trent as they are cause underground vibrations to the properties in the area), this is an issue awaiting resolution from them. Before any further development is allowed in that end of the village the sewerage problems need to be resolved, as adding 20+ properties at the Burgesses and a further amount at Mill House will have a major detrimental impact onto the residents that are already experiencing problems in that part of the village. A full survey of the existing drains should be undertaken with an action plan on what needs to be done to eradicate the problems.

Cllr I G Sadler explained that he felt that members were not consulted on this application before it was submitted for planning. A private meeting had been held with SSHA and he felt that it should have been a public meeting.

The Clerk explained that the initial meeting with the Housing Association, was to show the plans proposed, the Council did not make any recommendations only made observations. If the Parish Council make any comments in support or against the proposed application, this can be seen as predetermination.

The Clerk reminded members that any letters of complaint re planning applications from the members of the public, they should be encouraged to make individual comments directly to the District Council, so far for the Burgesses application there are only 51 registered public comments against the application. That is only a few in comparison to the 7000 residents in the village... A copy of a letter was received from local residents signed by 5 / 6 people this is only registered as one objection not 5 / 6.

- In addition we believe that it is in the Greenbelt and this would not comply with current Greenbelt regulations.
