#### 4. MATTERS ARISING FROM PREVIOUS MINUTES

4.1 Planning application 16/00565/FUL – Community Health Clinic, application for fencing and gates:-

Several letters of concern have been received from residents that live near the site, some of the comments made refer to the fencing encroaching onto the green space around the clinic. This is not the case, the fence will only be going around the paved areas and car park edge.

Cllr JK Hall whi had not been able to attend the last planning meeting, disagreed with the recommendation of the Committee.

Members fully debated the application at the last meeting, and to ensure that it was acceptable, in their recommendation they stated Recommend Approval subject to the Conservation Officers approval.

4.2 9 Hampton Grove, Kinver,

The applicant has contacted Steve Dores to ask for the removal of a dying silver Birch tree that is on the canal bank, he has agreed that it is dangerous and can be felled.
