4. FUTURE PROJECTS

Bench Policy update

Councillor G Sisley will review the benches that are in need of replacing / damage. He will report back to the Parish Clerk, who will endeavor to let the sponsors know the issues / reason why they are being removed and then the Technicians will be asked to remove them.

Walks

Councillor P Wooddisse reported that there are leaflets in the library to purchase and also the leaflets have been passed to Mr Andy Calloway to be scanned to go online. This will be an agenda item when there is an update.

Giants Well

The sink / bowl needs to be repaired still and Councillor G Sisley is looking into the options available. There are 3 costs for this project, tidying the bowl, tap and plumbing. Advice will be sought on the water connection from a plumber and the Maintenance Technicians.

Plastic Free Communities

It was agreed to take this off the agenda until there is an update.

Community wood / Orchard

Councillor P Wooddisse reported that he had spoken to Mr David Giddings from the FoKOS and he will update us at the next meeting.

Becoming a Wildlife Friendly village

Permission has been given for the purchase of Bat and bird boxes. The Clerk to order them ready to be installed and the Clerk / assistant Clerk to ask if the Scouts / Guides would be interested in being involved.

The Holloway Kinver

Defer until the next meeting when a decision has been made by the Council / Finance Committee with regard to the solar lights. It was agreed to ask the Technicians to look at cutting back the foliage on the roadway.

Farmers Markets

Support has been given from the Parish Council for using the gardens for a market using the High Street regeneration fund. The next stage will be to talk to the traders about the idea and get feedback / include them in the decision making process and ask if they would like to be part of the market. The Chairman / Councillor G Sisley to talk to the traders / drop in leaflets. The target for having a market mid to end of August 2021. Clerk to investigate with the insurers what cover etc is required.

The following footpaths were reported:-

FP23 from the KSCA has been reported as having manure at the side.

FP23 the steps have disappeared and the stile needs repairing and has been reported to Staffordshire County Council, in addition it was requested to replace the stile with a kissing gate at the same time.

FP opposite Living Springs needs to be checked.

The footpath that was cleared last year along the Bridgnorth Road needs the hedges to be cut back as walking on the footpath is difficult, this needs to be reported to the County Council urgently.
